## Appendix to the Admissions and Transfer Regulations

## Legislation taken into account in the admission procedure and certain provisions concerning their application

- 1. Nftv.: Act CCIV of 2011 on National Higher Education.
- 2. Felvr.: Government Decree 423/2012 (XII. 29.) on the admission procedure to higher education (Felvr.)

Section 41 of the Government Decree also applies to religious education programmes conducted by ecclesiastical higher-education institutions; it confers regulatory authorisation and, furthermore, requires statistical data provision to the Educational Authority by 15 October, and contains the possibility of admission by agreement and of dual training under Section 83 (5) of the Nftv.

3. **Ákr**.: Act CL of 2016 on the General Administrative Procedure.

The admission procedure is not an administrative procedure; therefore, the rules of the Ákr. do not apply to the admission procedure itself. However, they are applicable in certain special procedures conducted within the admission procedure (recognition procedure and appeal procedure).

- 4. Esély. tv.: Act CXXV of 2003 on Equal Treatment and the Promotion of Equal Opportunities.
- 5. **Elism. tv.**: Act C of 2001 on the Recognition of Foreign Certificates and Diplomas.
- 6. Ltv.: Act LXVI of 1995 on Public Records, Public Archives and the Protection of Private Archives.
- 7. Info. tv.: Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information.

From the entry into force of these Regulations, the Act applies to the College's website content related to admission information and the admission procedure, including the publication of these Regulations on the website.

- 8. **GDPR**.: Regulation (EU) 2016/679 of the European Parliament and of the Council (27 April 2016) on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, repealing Directive 95/46/EC (General Data Protection Regulation).
- 9. Btk.: Act C of 2012 on the Criminal Code.
- 10. Szabs. tv.: Act II of 2012 on Infractions, Infraction Procedures and the Infraction Records System.
- 11. Ptk.: Act V of 2013 on the Civil Code.

The provisions of this Act that follow from the Nftv., from other legislation taken into account in the admission procedure, and from these Regulations shall apply, in particular those concerning the determination of legal capacity.

- 12. **Nftvhr**.: Government Decree 87/2015 (IV. 9.) on the implementation of certain provisions of Act CCIV of 2011 on National Higher Education.
- 13. **Ir**.: Government Decree 335/2005 (XII. 29.) on the general requirements for records management of publictask performing bodies.
- 14. **BA-MA KKK** r.: EMMI Decree 18/2016 (VIII. 5.) amending EMMI Decree 8/2013 (I. 30.) on the Programme and Learning Outcomes Requirements for higher education vocational programmes, bachelor's and master's programmes, as well as on the common requirements for teacher training and the Programme and Learning Outcomes Requirements for individual teacher training programmes.
